### Ceigall India Limited Wins Rs 603-Crore NHAI Contract for 6-Lane Spur Project in Punjab

**New Delhi, March 27, 2026:** Ceigall Infra Projects Private Limited (CIPPL), a wholly owned subsidiary of Ceigall India Limited ('CIL'), has received a Letter of Award (LOA) from the National Highways Authority of India (NHAI) for the construction of a 6-lane access-controlled spur road in Punjab.
